Sub: Admission to Diploma in Education (Special Education, DHH, MR, VI, ASD, CP and DB) programmes for the academic session 2014 -15: reg.

Madam/Sir,

In the light of the feedback from various stakeholders, the Council has decided that for the academic year 2014-15 the RCI approved institutions may be permitted to follow the criteria of their respective states for admission to Diploma in Education (General Education) subject to the condition that an aspirant for the said course should have minimum 50% marks in the qualifying examination (i.e., 10+2) with relaxation of marks and reservation of seats as per the instructions of the Government.

- 2. The candidates shall be selected on the recommendation of an admission committee consisting of the Head of the organization/institution and three other members, one of whom should belong to SC/ST and one should be from RCI approved institute in the state. The merit list shall be prepared based on the marks in the above mentioned qualifying examination.
- The above procedure will be followed for the academic year 2014-15 only on an experimental basis. There will not be All India Aptitude Test the year 2014-15.
- The institutions should complete the process of admission latest by 15<sup>th</sup> June 2014.
- All the institutions should send the following to the Council in the prescribed format (Annex-A) latest by 20<sup>th</sup> June, 2014:
- (i) Name and address of the members of the Admission Committee with their contact number, address and e-mail.
- (ii) List of admitted candidates as on 15<sup>th</sup> June 2014 in the prescribed format along with the criteria followed for admission.
- List received after 20<sup>th</sup> June, 2014 will not be considered.
- The classes for the academic session 2014-15 should commence from 1<sup>st</sup> July 2014.
