
Madam/Sir,

Office Order

The Council has conducted joint assessment for extension of proposals for the academic session 2018-19. Based on the Joint Assessment Report (JAR) few extension proposals are regretted as these institutions had obtained scores less than the prescribed score.

2. As per guidelines, the institution who has not secured the minimum prescribed score for grant of approval, they may make appeal to this Council within 15 days of receipt of the regret letter with Rs. 5000/- as an appeal fee. The Council has discontinued the system of re-inspection.

3. Keeping in view of the above, it has been decided to constitute following committee of Senior officers/Experts for considering such cases whose extension proposal has been regretted by the Council for the academic session 2018-19 and those who made appeal before the Council along with appeal fee.:

The Committee shall consider all such cases based on their representations / presentations and shall recommend either rejection or re-consideration / approval of extension proposal for maximum one year. The recommendation of this Committee shall not be binding but if approved by the Chairperson of the Council, further action shall be taken accordingly.

4. The above committee shall meet as and when the date of meeting is proposed by the Council for this purpose and place its report to the Council at the end of the day on which the meeting is conducted.

5. It is to mention here that the Head of the Institution / Course Coordinator (appointed at least one year before in the said institution) will present their case specially the parameter in which they scored less than the prescribed score. For this, the institutions will be given **05(five) minutes for presentation (Power Point / Orally)** and submit the documentary evidence to the satisfactory of the Committee constituted for this purpose. In any case, no extra time or no second chance shall be given under any circumstances.


