

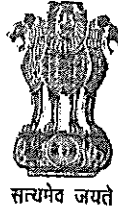


Madam/Sir,

It is to apprise you that the Rehabilitation Council of India has been constituted for regulating and monitoring the training of rehabilitation professionals and personnel promoting research in rehabilitation and special education and the maintenance of Central Rehabilitation Register vide Rehabilitation Council of India Act, 1992 and its amendment Act of 2000.

The Council in its 76<sup>th</sup> meeting of Executive Committee held on 29<sup>th</sup> August, 2017, has decided to obtain No Objection Certificate (NOC) by States/UT's Administrations for any NGO to run the approved training programme of this Council in the area of disability as it is mandated in the RCI Act, 1992 and its subsequent regulations. It has also been decided that from the academic session 2019-20 onwards the NOC shall be acceptable only in the prescribed format/procedure of this Council which is enclosed herewith for your perusal.

You are therefore, requested to direct your field officers to submit reports according to the prescribed format of the Council and facilitate you to send the NOC on the format prescribed for this purpose to this Council within the last date as stipulated in the advertisement notice of new courses of this Council from time to time.
