The tender processing committee will open the financial bids of only those bidders who stands qualified on the basis of details provided in technical bid.

Scanned copy of bid documents etc. has to be submitted online at <http://eprocure.gov.in/e-procure/app> along with the Technical and Financial bid and scan copy of EMD and Tender fee should be uploaded as per schedule mentioned above.

EMD and Tender Fee in original should be submitted in a sealed envelope superscribed with **“SUPPLY, INSTALLATION AND COMMISSIONING OF ONE NEW ELEVATOR AT REHABILITATION COUNCIL OF INDIA BY REPLACING EXISTING ELEVATOR”**, addressed to Member Secretary, Rehabilitation Council of India, B-22 Qutab Institutional Area, New Delhi and deposited (in original) in the tender box kept at despatch section of RCI on or before 09.12.2020 by 1430 hrs.
