

### Circular

To monitor and regulate the approved training programmes in the field of disability rehabilitation & Special Education and to create awareness in the field of disability, seven ZCC has been functioning in seven zones covering 33 States since 2001. During the enactment of the RCI Act in 1992, the number of approved institutions were very few and thereafter, the number of new programmes and approved institutions have grown in geometrical progression and in recent years, activities of RCI has diversified and expanded considerably. Each ZCC was given the responsibility to undertake the Zonal activities in 04-05 states in their respective zone which has now become a task with extended field. For effective monitoring and promotion of RCI's activities in all the States, the General Council of RCI accorded approval to extend ZCC from 07 to 14 with appropriate distribution of states across the Country since 2017-18.

Accordingly, Circular on public domain of RCI was issued on 03.05.2017 and subsequent corrigendum thereafter stating the invitation of applications for nominations as Member or Zonal Coordinator of ZCC of RCI in respective zone. Last date of receipt of applications for these positions was 21<sup>st</sup> August, 2017. Council received 51 applications for Zonal Coordinator and 79 for Members.

These applications were scrutinized by the committee based on the criteria mentioned in the guidelines for nominations as Member / Zonal coordinator and submitted their recommendation. The Council had constituted a committee under the Chairmanship of Dr. Kamlesh Kumar Pandey, Chairman, RCI for selection of suitable candidates for nomination of these honorary positions which met on 14.09.2017 at RCI and examined the report of Scrutiny Committee for the positions of Zonal Coordinator and Members.

Based on detailed examination of applications of eligible candidates and in the light of suitability of their candidature and norms of eligibility etc. and the recommendation of the screening committee, the Council is pleased to nominate following candidates as Zonal Coordinators / Members / Conveners as indicated below:


