Sub: Admission to RCI approved Diploma/Certificate level programmes for the academic session 2015-16

Madam/Sir,

With reference to the subject cited above, I am to inform that for the academic year 2015-16, it has been decided that All India Aptitude test will not be organized for admission to RCI approved Diploma/Certificate level programmes. The institutes may admit students on their own following the criteria of their respective States for admission. The minimum percentage of marks in the qualifying examination has been decided as 50% marks with relaxation of marks and reservation of seats as per the instructions/guidelines issued by the respective States. The candidates may be selected on the basis of merit in the qualifying examination and on the recommendation of a Committee consisting of the Head of the organization/institute and three other members, one of whom should belong to SC/ST and one should be from RCI approved institute in the State.

2. The institutions should complete the process of admission latest by 15th July, 2015.
3. All the institutes should send the following to the Council latest by 20th July, 2015.
 - (i) Name and address of the members of the Committee with their contact number and e-mail
 - (ii) List of admitted students as on 20th July, 2015 in the enclosed format alongwith merit list including names of the waitlisted candidates.
 - (iii) Lists received after 20th July, 2015 will not be considered.
 - (iv) The classes will commence from 1st August, 2015.
 - (v) No request for extension of last date for admission and relaxation in admission criteria will be considered.
 - (vi) Admission should be made only for the approved intake and in no case it should exceed the same.
