**GUIDELINES FOR INSTITUTIONS FOR ADMISSION TO DIPLOMA IN EDUCATION
(SPECIAL EDUCATION DHH, MR, VI) FOR THE ACADEMIC SESSION 2011 – 12**

1.	The admission to Diploma in Education (Special Education DHH, MR, VI, CP, DB, ASD) for the academic session 2013 – 14 will be strictly on the basis of merit of All India Online Aptitude Test 2013.
2.	The result of the All India Online Aptitude Test 2013 will be declared and displayed on the website of RCI www.rehabcouncil.nic.in on 23rd July, 2013
3.	The candidates who have qualified on the All India Online Aptitude Test may approach any RCI recognized Institute for admission and submit their request/application for admission between 23rd July 2013 and 30th July 2013.
4.	In case more than one applicant obtaining equal marks in the All India Online Aptitude Test, admission to be made on the basis of merit in 10 +2 examination in addition to the marks obtained in All India Online Aptitude Test
5.	Last date for receipt of application at the respective Institute from the qualified candidates of the All India Online Aptitude Test for admission for the academic session 2013 -14 will be 30th July 2013
7.	The Institute should finalize the list of selected candidates based on the applications received from qualified candidates, following the reservation policy of respective State and merit of the All India Aptitude Test 2013. The list of selected candidates should be displayed on the notice board of Institutes at 10.00 A.M. on 31st July 2013. The institute must also intimate the selected candidates allowing them time to deposit their fees by 5th August 2013. No fee should be accepted 5th August 2013 .
8.	The list of admitted candidates who have deposited the fees by 5th August 2013 must reach RCI office by email rci.examinationcell@hotmail.com and/or exam_rci@rehabcouncil.org by 5th August 2013 before 5.00 PM positively. Supplementary list sent after 5th August 2013 would not be considered by RCI.
9.	If any seats, after closing of admission on 5th August 2013 as mentioned above, are lying vacant, the same should not be filled until further instructions are received from RCI.
10.	The above guidelines should be strictly followed by the Institutions, failing which admission to these Courses may not be treated as valid.

INSTRUCTIONS TO THE CANDIDATES SEEKING ADMISSION IN DIPLOMA IN EDUCATION (SPECIAL EDUCATION, DHH, MR, AND VI) PROGRAMMES FOR THE ACADEMIC SESSION 2011-12.

- 1 The result of the All India Online Aptitude Test 2013 will be declared and displayed on the website of RCI www.rehabcouncil.nic.in **23rd July 2013.**
- 2 The admission to the Diploma in Education (Special Education - DHH, MR, VI, .CP, DB and ASD) programmes for the academic session 2013-14 will be strictly made as per merit obtained in the All India Aptitude Test 2013.
- 3 The qualified candidates whose 12 + 2 result is awaited may seek provisional admission and deposit the fee before **5th August 2013.**
- 4 The candidates who have qualified in the All India Aptitude Test may approach any RCI recognized Institute conducting the said programme for admission and submit their request/application for admission between **23rd July 2013 and 30th July 2013.**
- 5 The institute will finalize the list of selected candidates who have applied for admission at the respective Institute strictly as per merit of the All India Aptitude Test on **31st July 2013** and display the same on their notice board on **31st July 2013.**
- 6 The Institute will also intimate the selected candidates allowing them time to deposit the fee.
- 7 In case the selected candidates fail to deposit the fee till **5th August 2013**, her/his admission shall stand cancelled and the seat will fall vacant.
