4. Educational Qualification

Essential : (i) Degree from a recognized University or equivalent (ii) Five years experience in administration/accounts

Eligibility (deputation) : Officers under Central/State Government/ Universities/ recognized Research Institutes/ Public Sector Undertaking/Semi Government/Autonomous/Statutory Organization.

(a) (i) Holding analogous posts on regular basis, or (ii) Officer holding regular posts in the grade pay scale of Rs. 4000-6000 with ten years regular service.

General Conditions:

1. Applications from the eligible candidates in the prescribed format (either to be downloaded from RCI website www.rehabcouncil.nic.in/appformt.doc or obtained from RCI Office) along with attested copies of testimonials/certificate to reach to **Member Secretary, Rehabilitation Council of India, B-22, Qutub Institutional Area, New Delhi-110 016** by 20-12-2010.
2. Those who fulfil the prescribed qualifications and eligibility criteria may send their application along with attested copies of their certificates in support of their candidature for the post.
3. Candidates belonging to OBC/SC/ST/PH categories should enclose certificate to that effect.
4. The applications, must be sent through Proper Channel along with attested copies of five years ACRs, Integrity and Vigilance Clearance Certificates.
5. The candidate selected on deputation will be governed by the instructions issued by DOPT from time to time as applicable to Central Government Departments/Organizations. The maximum age limit for appointment on deputation shall not exceed 56 years as on 20-12-2010.
6. The applications received without required documents will summarily be rejected. Advance copy of the application may be considered, if followed by application received through proper channel.
7. Only short listed candidates will be called for interview. Council also reserves the right to cancel or withdraw the vacancy without any reasons, if felt necessary.
