Sir/Madam

With reference to the above cited subject, it is informed that the Rehabilitation Council of India is in the process of revising the course curriculum, norms and duration for B.Ed. Spl.Ed. and M.Ed. Spl.Ed. on the pattern of NCTE Regulation 2014, Notification No. 346 dated 1.12.2014. These modifications are required to establish the parity between Special Educators with general teachers (for recruitment purposes) The revised norms shall be communicated to you at the earliest.

**You are, therefore, requested not to initiate admission for the academic session 2015-16 till further directions from the Council.**

The existing training institutions offering special education programmes will be given revised approval letter, if they choose to follow new norms. The new training institutions who have already applied and the existing institutions who are willing to continue the training programme with the two year duration and other modifications as may be proposed shall furnish their letter of consent to RCI in the enclosed prescribed format within 30 days from issue of this letter.
