CIRCULAR

Sub: Processing of Proposals as fresh for the academic session 2018-19 which were submitted for the academic session 2017-18:-reg.

This is for information to all concerned that the Council's had received several fresh proposals without the State NOC for the academic session 2017-18. The Council had sent letter No. 8-A/Policy(Recog.)/2009/RCI dated 23/03/2017 to all State Government with regard to issuance of State NOC to the concerned institutions., whereas State NOC received till 06/04/2017 (issued upto 31/03/2017 by the State Government) were considered for the States where assembly elections were held in February/March, 2017 (such as Goa, Manipur, Punjab, Uttarakhand and Uttar Pradesh).

2. As per Council's decision, the remaining proposals were to be considered for 2018-19 provided the State NOC and the consent of the institutions are received in the Council on or before 30/09/2017. As per Council's Circular No. 8-A/Policy(Recog.)/2016/RCI dated 28/04/2017 and 8-A/Policy(Recog.)/2009/RCI dated 16/10/2017, only two fresh proposals from any institute across country will be considered for processing for the academic session 2018-19.

3. Accordingly, as per record of the Council, a list of 41 eligible fresh proposals are enclosed whose State NOC and their consent letter has been received by the Council as on 30/09/2017 (which was the last date for receiving the consent from the institution).

4. It is desired from all concerned to check the list and if their name is missing, may please inform the Council on e-mail rehabstd@nde.vsnl.net.in or fax No. 011-2653 4291 on the enclosed format latest by 15/01/2018 for consideration of their proposals for the academic session 2018-19. Information received after 15/01/2018 shall not be considered for deputing visiting experts on earlier NOC, and they shall be subjected to be considered along with fresh proposals of 2018-19 under the new norms of the Council as circulated vide Council's Circular No. 8-A/Policy(Recog.)/2009/RCI dated 16/10/2017 (copy enclosed) .

CIRCULAR

Sub: Instructions on processing of proposals for the academic session 2018-19:-reg.

The following criteria shall be ensured in terms of processing proposals for fresh recognition and extension of recognition of RCI approved training programmes for the academic session 2018-19:

1. All those proposals will be considered for deputing the visiting experts team for ascertaining the genuineness of institution, received in the prescribed formats fulfilling the following requirements:
 - i) who have obtained online proposal ID. The proposal received without online proposal ID will not be entertained for further processing.
 - ii) whose State NOC has been issued by 31/10/2017 and received in the Council in original latest by 7th of Nov. 2017. In no case this date shall be extended.
 - iii) who have valid registration certificate (as on 30/09/2017) under Section 51 of under RPwD Act, 2016 or Section 52 of PwD Act, 1995, in the name of the institute who has applied.
 - iv) Institute must have their own special school. However, institute not having their own Special School, may sign MOU with any one nearby special school of the district. The respective special school must ensure that they sign MOU with only one institute per category of disability, located nearby. The MOU should be signed before the last date of submission of NOC i.e. 31/10/2017. Council shall consider only one MoU (per category of disability) for one special school.
 - v) who have submitted original undertaking on Non-Judicial Stamp Paper of Rs. 50/- as prescribed in the application form.
 - vi) who have submitted proof of endowment fund of Rs. 3.00 lakhs for one course and Rs. 1.00 lakh for subsequent courses.
 - vii) who have submitted processing fee within last of submission of online proposal i.e. 30/09/2017
 - viii) who have submitted other necessary documents as contained in the application format.
2. Only two fresh proposals will be considered from any institute for the academic year 2018-19 onwards across the country.
3. Incomplete / late received proposals will be regretted.
4. It is also for information to all concerned that the system of evaluation and format thereto are under revision for both fresh and ongoing programmes, as such the institutions may be evaluated according to new formats and guidelines for the next academic session onwards (i.e. 2018-19 onwards).






