This is in continuation to Council's Circular No. 5-14/2016-RCI dated 22.11.2016 and Circular No. 7-16/2016-RCI dated 2.12.2016 regarding entrusting the responsibilities to the respective National Institutes for grant of permission to conduct CRE programme to the RCI recognized training institutes.

2) In this context, the Council is in receipt of several queries regarding grant of permission to conduct CRE programme at their institutes. Accordingly, the following clarifications is hereby made for information to all concerned:-

3) The respective National Institutes namely Ali Yavar Jung National Institute of Speech & Hearing Disabilities (Divyangjan) , Mumbai, National Institute for Empowerment of Persons with Multiple Disabilities (Divyangjan), Chennai, National Institute for the Empowerment of Persons with Visual Disabilities (Divyangjan) Dehradun and National Institute for Locomotor Disabilities (Divyangjan) Kolkata have been authorized by the Council to grant CRE Programme without financial assistance(maximum 3 programmes in a financial year) to only those RCI approved training institutes conducting Certificate/Diploma level courses in the respective area of disability for which maximum intake could not be more than 30 as per the provisions of CRE Norms available on the Council's Website.

4) All other proposals such as CRE programmes with financial assistance /Workshop/Seminar/Conference etc submitted by the RCI approved training institutions /Universities /CRC/Registered Associations/Organizations will be considered by the Rehabilitation Council of India only.

5) All National Institutes should clearly mention in the approval letter that the approval granted is as per RCI norms . Approval of CRE programme to any institute in contravention to above provisions and also against the prescribed norms of the Council for award of CRE programme, shall neither be entertained by the Council nor the CRE points shall be granted to the participants of such programmes. Also it may be taken up for seeking clarification from the NIs concerned. Participants are advised to ensure the authenticity of CRE programmes in which they are taking part.
