Sub: Clarification in respect of ongoing D.Ed.Spl.Ed. training programmes till 2020-21 – reg.

This is in continuation to the Council's earlier circular no. 7-91/Expert Committee/2019/RCI dt. 12 August 2021. All heads of the RCI approved training institutions are hereby informed that candidates admitted in different diploma level training programmes till academic session 2020-21 will continue their courses as per the respective syllabus.

2. The new training programmes D.Ed.Spl.Ed.(HI), D.Ed.Spl.Ed.(VI), D.Ed.Spl.Ed.(IDD) developed by the Council after convergence as mentioned at para-2 of aforesaid circular will be implemented from the academic session 2021-22 onwards with an intake of 35 (maximum) per batch and it does not have any impact on the ongoing courses till academic session 2020-21. This has also been clarified at para-4 in the aforesaid circular (copy enclosed).

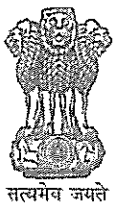

CIRCULAR


In the light of RPwD Act, 2016 and based on the recommendations derived during the National Workshop held on 6-7 June 2019 at Guwahati and the subsequent several meetings of the Core Committee on convergence of teachers training programmes and in consonance with of NEP 2020, development of new training programmes in special education in various disability specializations were approved by the General Council of RCI in its meeting held on 7/8/2020.

2. In exercise of the powers conferred under section 18 of the RCI Act, 1992, after convergence, the following **new training programmes** at diploma level in different disability specialisations have been developed:

- i. Diploma in Education Special Education (Visual Impairment) - D.Ed.Spl.Ed.(VI)
- ii. Diploma in Education Special Education (Hearing Impairment) - D.Ed.Spl.Ed.(HI)
- iii. Diploma in Education Special Education (Intellectual and Developmental Disabilities) - D.Ed.Spl.Ed.(IDD)

3. The above training programmes as approved by the Executive Committee of RCI in its 83rd meeting held on 30/7/2021 will henceforth be implemented from the academic session 2021-22 at RCI approved training institutions. The new curriculum of these training programmes is available on the Council's website: www.rehabcouncil.nic.in

4. The existing training programmes "D.Ed.Spl.Ed.(VI), D.Ed.Spl.Ed.(HI), D.Ed.Spl.Ed.(ID), and D.Ed.Spl.Ed.(ASD)" will be discontinued w.e.f. the academic session 2021-22. However, candidates who already given admission till 2020-21 will continue their courses.
