CORRIGENDUM

In light of the decision taken in the 76th Executive Committee Meeting held on 29th August 2017, the Council has revised the 'Norms of the M.Phil. Clinical Psychology Course' as mentioned under :


- I. In Para 3.0 'Requirements to start the M.Phil. in Clinical Psychology Course':
 1. There shall be minimum two clinical psychology faculty members on full time basis at the department , as specified below:
 - i. At the level of Associate Professor or above –one member
 - ii. At the level of Assistant Professor /Lecturer or above- one member
- II. In Para 2 of Point 3.0 'Guidelines for faculty requirements and promotion' are as follows
 - i. Assistant Professor: M. Phil. Clinical Psychology (with or without experience)
 - ii. The faculties appointed as Assistant Professor /Lecturer can be on full time contractual basis and with or without Ph.D and NET/SLET.
 - iii. All the faculties as mentioned in the guidelines will be serving as Teaching Faculty, Clinical Supervisors and as Research Guide.
- III. In Para 4.1 'Requirement of faculty ' :

Since this is a fulltime clinical training course, the number of candidates being trained at the centre will depend on number of qualified fulltime faculty members working in the department, the clinical facilities and infrastructure available (refer 3.3 & 3.4). In order to make the training effective therefore, the intake of candidates in an academic year shall not exceed the following ratio.

Associate Professor/Additional Professor/Professor - 1:4
Assistant Professor -1:2
- IV. In Para 2 of point 4.1 :

Part-time/ superannuated qualified professional members may render their input as deemed necessary to effective/ smooth conduct of the course as Guest Faculty member. However, these members are not considered as "Core Faculty" and annual intake of candidates shall not be linked to the presence of these faculty members at the centre.

Remaining Norms as mentioned in the syllabus shall remain the same.
