Madam/ Sir,

With the reference to the subject mentioned above, I am to inform that for the academic session 2017-18, the institutes may admit students on their own to RCI approved Diploma/Certificate level programmes following the criteria.

1. The minimum percentage of marks is 50% in the qualifying examination for the relevant programme/course (council's circular, 7-128/RCI/2014 dated 29/10/2014 and 25/02/2015 should be referred, **Enclosure-1**).
2. Relaxation of marks and reservation of seats as per the instructions/ guidelines issued by the respective State/ Union Territories.
3. Vertical and Horizontal reservation of respective categories viz. SC, ST, OBC, PWDs, Women, Dependence of the Freedom Fighter etc. has to be ensured as per the directions/rules of respective State /Union Territories.
4. The candidates should be selected based on the following parameters for admission to relevant programme/course and on the recommendation of a Committee consisting of the Head of the organization/institute and three other members, one of whom should belong to SC/ST and one should be from RCI approved institute in the State:



6. The Institutions should complete the process of admission latest by 20th June, 2017.
The details of admission schedules are as under:

7. Lists received after 20th June, 2017 will not be considered.
8. The classes will commence from 4th July, 2017.
9. No request for extension of last date for admission and relaxation in admission criteria will be entertained.
10. Admission should be made only for the approved intake and in no case it should exceed the approved numbers of seats.
11. Transparent System of Admission is sole responsibility of training centre. Any litigation in the admission/ process should be dealt by the respective institute only.
12. Candidates once admitted shall not be allowed to be exchange or replaced.
13. Vacant seats if any, shall be first filled up by the wait listed candidates by 30.06.2017 positively, under intimation to the Council.
14. After 30.06.2017 no vacant seats shall be filled without prior permission of the Council.
15. Any deviation from the timeline / parameters shall be brought to the notice of this Council only in case of genuine reason. Changes may be only after obtaining prior approval from the council.
16. The cost of application form shall not be more than Rs. 300/-.
17. Timeline for new institutions awaiting approval for current academic session (2017-18) shall be communicated separately.


