Sub: Exemption of fee for PwD candidates to attend CRE programmes approved by Council with financial assistance -reg.

As per the RCI Act-1992, the Council is mandated for the development, standardization and monitoring of training programs in the field of disability rehabilitation and special education. In addition to this, Council is also responsible to ensure that professionals working in the disability sector must update and upgrade their knowledge and skills on a continuing basis by undergoing RCI's approved Continuing Rehabilitation Programme (CRE).

2. In pursuance of aforesaid provision, RCI's approved institutions are considered for permission to organize 3 & 5 days CRE programmes on various approved topics with and without financial assistance by the Council. Candidates desirous to undergo the approved CRE programmes are required to pay the prescribed fee as mentioned below :-



3. In order to minimize the financial burden from the candidates belongs to PwD category , it has been decided by the Council that such candidates shall be exempted to pay the prescribed fee for CRE programme for which financial assistance is given by the Council based on the following condition.

- Candidates have to submit disability certificate issued by the competent authority as per the Provision of PwD Act, 1995 to the institutions.

4. The above said scheme will be implemented from the next F.Y. i.e. 2017-18 onwards.

5. This issues with the approval of the Competent Authority.
