**CIRCULAR**

**Sub:** Consideration of proposals with and without State NOC for the academic session 2017-18 onwards:-reg.


The Council had invited proposal(s) for grant of approval to conduct RCI's training courses in the field of disability rehabilitation vide its Circular dated 23/06/2016 which was placed in the public domain on the Council's website and various leading news papers. As per the aforesaid circular, last date for receiving the proposals (completed in all respect, this includes NOC from State Government) was 15/09/2016, subsequently, the date was extended up to 31/12/2016.

2. It has been observed that many proposals are not containing State NOC or even State NOCs are received after 31/12/2016 whereas the proposals have already been received by the Council within the prescribed last date.

3. The matter was placed before the General Council (GC) of RCI in its meeting held on 22/02/2017 and it has been decided that;

(i) Fresh Proposals for the academic session 2017-18 received timely through on-line and offline mode, wherein NOC from State Government was not available, shall be considered for the academic session 2017-18 only in cases where State NOC till 28/02/2017 is issued and received in the Council latest by 06/03/2017. Remaining proposals wherein NOC from State Government issued after 28/02/2017 shall be considered and processed for the academic session 2018-19 subject to willingness of the concerned institution.

(ii) RCI shall issue notice to all State Governments under Section 24(9) of RCI Notification dated 27/03/1997 which states that "On receipt of the an application from an organization for permission to start new rehabilitation professional course, the Council shall call for if not done by the organization, the recommendations/views of the State Government. In case the recommendations/views of the State Government are not received within a period of ninety days, the Council shall be entitled to process the application on its own with the support of his committees and thereafter take such decision as it deem necessary" and subsequently the Council will initiate necessary action as provided U/s 24(9) of notification referred above.
