Subject: Extension of last date of admission to RCI's approved Diploma /Certificate level Courses- Reg.

Kind Attention : The Heads/Course Coordinators of RCI approved Institutions offering Certificate / Diploma Level Courses / Programmes

The Council has been receiving several requests from the RCI approved training institutions for extension of last date for admission to diploma and certificate level courses for the academic session 2016-17 on the ground of late declaration of XIIth result in many states.

2. Keeping in view the genuine problem of late declaration of XIIth result and consequently less number of filled seats in D.Ed/Certificate Courses in many states, it has been decided to extend the last date for admission to the above said courses from 30th July, 2016 to 20th August, 2016 at par with last year decision.
3. Accordingly, the final list of candidates admitted to diploma and certificate level courses to be submitted to the Council on 21st August, 2016 by 5.30pm through email. Hard copy of the list of admitted candidates has to be sent by registered /speed post latest by 25th August, 2016.
4. The list of selected candidates has to be displayed on notice board of the training institute as well as to be uploaded on its website for information to all concerned on 21st August, 2016 by 5.30pm.
5. Vacant seats if any, shall be first filled up by waitlisted candidates by 30th August, 2016 positively under intimation to the Council. After it, no vacant seats shall be filled up without prior permission of the Council.
6. Classes for the academic session 2016-17 will commence from 21st August, 2016, if not started as yet.
7. The institutions offered this facility shall be responsible to complete the required no. of teaching & practical hours, as scheduled, by conducting extra classes.
8. This is the last and final extension of date. No further request in this regard shall be considered on any ground.
