- II. Conduct of classes for all RCI's approved courses from certificate, diploma, degree , masters and above for previous and current academic sessions i.e. 2019-20 & 2020-21.
- III. Conduct of 2nd year examinations of all diploma, degree , masters and above level courses .
- IV. To streamline and bring transparency in the entire inspection process.
- V. Grant of CRE Status to webinars to be conducted by TTIs.
- VI. Expeditious issuance of CRR Certificate.
- VII. Any other matter with the permission of chair.
