CIRCULAR

Sub: Consideration of State NOC issued by the State Govt. till 31/03/2018 for the academic session. 2019-20:-reg.

This is for information to all concerned that the Council has received the State Govt. NOCs on the proposals applied for the academic session 2018-19 in the old format of RCI though the Council has requested vide letter No. 8-A/Policy(Recog.)/2009/RCI dated 17/10/2017 to all State Government to issue NOC in new format and the Council will not accept the State NOC in old format from the academic session 2019-20.

II. Keeping in view the other procedural complications and facilitating to training institute it has been decided that the Council may now accept the State NOCs issued upto 31st March, 2018 in old format for the academic session 2019-20 with regard to those proposals / institutions who have minimum 3 years old valid PwD registration certificate and have their own special school in the respective disability area and also they fulfill other criteria for granting recognition for the academic session 2019-20.

III. In view of the above, it is requested to all concerned that if the institute (who submitted their online proposal on time i.e. by 30/09/2017 and hardcopy of the online proposal on time i.e. by 15/10/2017) and is agreed to consider its proposal for the academic session 2019-20, applied for 2018-19 whose NOC has been received in the Council upto 31st March, 2018, their proposals may be considered for 2019-20 provided the institute submit their consent latest by 30th June, 2018 on the format enclosed. If the consent is not received by 30th June, 2018, the submitted proposal will be regretted. The State NOCs issued from 1st Nov.2017 to 31st March, 2018 shall only be considered for academic session 2019-20 for these cases.
