4.	Scheme of the Test (Maximum Marks – 50)	i) Written test (Part-A) shall consist 50 objective type questions with multiple choices of answer relating to General English, General Study, current events, Reasoning/Numerical ability & Disability matters. All questions will carry equal marks. ii) Part-B shall consist of 02 descriptive questions relating to Noting & Drafting to assess the writing skills required for the subject post. Each question will be of 10 marks. iii) The question paper shall be of Graduate level. iv) There will be no negative marking. v) Papers will be set in English language only.

2. All candidates are required to bring original certificates relating to educational qualification & experience for verification, failing which they will not be permitted to appear in the written test.

3. No interview shall be conducted. Candidates shall be selected only on the basis of performance in written test. In case of two candidates having equal marks, the candidate senior in age shall be preferred.

4. No TA/DA shall be paid by the Council for attending the test.
