### CIRCULAR

**Sub:** Consideration of proposals (fresh and extension) received and extension of last date for receiving hard copy of proposals for academic session 2017-18:-reg

The Council has been receiving several requests from the RCI approved training institutions and other new institutions for extension of last date for submission of hard copy of proposal for the academic session 2017-18.

The matter was placed before the Executive Council of RCI in its meeting held on 14-10-2016 and decided the following:

1. In-terms of proposals received for fresh & extension for the academic session 2017-18
  - (a) Fresh proposals received without online application & proposal ID will be regretted, except proposals/applications received from North-Eastern States, Andaman & Nicobar, Lakshadweep, J&K and other inaccessible / remote areas.
  - (b) Those already applied on-line and got proposal ID, hardcopies of such fresh proposals will be received in the Council with a penalty of Rs.5000/- till 30<sup>th</sup> November, 2016. **No further date will be extended beyond 30<sup>th</sup> November, 2016.**
  - (c) In case of on-going institutions the last date for proposals for extension of approval without online or hardcopies submission has been extended till 30<sup>th</sup> November, 2016 with a penalty of Rs.15,000/-. **No further date will be extended beyond 30<sup>th</sup> November, 2016.**
  - (d) The procedure for consideration of proposal for conduct of course shall be initiated only on receipt of State NOC. **NOC from only District Authorities shall not be considered.**
2. The Council has also decided **to consider maximum only 02 (two) fresh proposals** received from any organization/Society across the country from the academic session 2017-18.
