

**Invitation of Proposals to conduct M.Ed. (Special Education) Course through Open & Distance Learning Mode**

Rehabilitation Council of India, a Statutory Body under the Ministry of Social Justice & Empowerment, Department of Empowerment of Persons with Disabilities (Divyanggan), Government of India, invites proposals from Universities/National Institutes for starting M. Ed.Spl.Ed. (MR, HI & VI) Course through Open & Distance Learning Mode, proposed to be launched from the academic session 2018-19.

1. **Eligibility Criteria for the Universities / National Institutes :**

- I. National Open University / State Open University offering B.Ed. Spl. Ed. -ODL mode having prescribed faculty to run M.Ed. Spl. Ed. -ODL is eligible for consideration, subject to prior approval of Distance Education Bureau (DEB).
  - II. Central University/ State University/ National institutes offering B.Ed. Spl. Ed. & M.Ed. Spl. Ed. courses in regular mode are eligible for consideration provided prescribed faculty in Spl. Ed. is available, and they have statutory mandate to run courses in distance mode along with necessary prior approval of Distance Education Bureau (DEB).
2. **How to apply:** The Universities/ National Institutes fulfilling the above criteria may obtain the detailed Norms, Guidelines and Application Form from the Council's website- [www.rehabcouncil.nic.in](http://www.rehabcouncil.nic.in) . The duly filled in Application Form should be submitted along with relevant documents and processing fee of Rs. 10,000/- in the form of Demand Draft favouring "Member Secretary, Rehabilitation Council of India", payable at New Delhi.
3. The Last date of submission of proposal along with relevant document is 1<sup>st</sup> July, 2018 .
4. After processing the Application Form, the short-listed Universities/National Institutes will be required to send the inspection fee of Rs 40,000/-. (This will be intimated by the Council to the applicant organization),
5. If approval is granted , an approval fee @ Rs. 30,000/- per year / batch is also chargeable.
6. The Council may impose any other condition, deemed necessary, on the applicant institution, before or during the conduct of the Course.
