
Subject: Penalty for providing relaxation for renewal of registration.

With reference to the above subject a circular of the Council was issued on 22.07.2016 (copy enclosed for ready reference).

In the circular issued on 02.03.2017 for revision of fee of registration the instruction on penalty for providing relaxation for renewal of registration to be imposed on candidates beyond one year was missing. (copy enclosed for ready reference)

This is to clarify to all that as per earlier provision, a penalty of Rs. 1,500/- shall be imposed on candidates for providing relaxation for renewal of registration beyond one year. The revised fee and the penalty is effective from 1st April, 2017 as contained on the circular dated 22.07.2016.


