### Circular

#### **Sub: Addition/Amendment to the guidelines of ZCC**

The guidelines for Zonal Coordination Committees of RCI containing 16 points and Application Format for nomination/appointment of ZCC Coordinators/Members were circulated vide RCI Circular No.10-75/ZCC/2017/RCI dated 3<sup>rd</sup> May, 2017. Following additions/amendments are hereby made in the Guidelines as given below:

#### **Addition:**

**Point 9:** The following is added:


- (i) Members other than Zonal Coordinators shall also be entitled for re-imburement of travelling allowance by Train only, limited to III<sup>rd</sup> AC and Dearness Allowance maximum upto Rs.1500/- per day.
- (ii) Zonal Coordinators and ZCC members shall be paid a token honorarium of Rs.2,000/- per visit/inspection while visiting any institution or any programme on the directions of RCI.

#### **Amendment:**

**Point 14.(i):** It was mentioned that RCI shall open 15 bank accounts in the existing parent bank account of RCI out of which 14 bank accounts shall be for each ZCC and one to be maintained by the Council to access funds by the Council for ZCCs. It was reviewed from accounting point of view and it is decided that ZCC Coordinator shall open a joint account in any Nationalized Bank only in the name of ZCC of concerned Zone of RCI with Zonal Convener as joint signatory of the account. This account shall be jointly operated by the Zonal Coordinator and Zonal Convener of the concerned zone only or as per the directions of RCI from time to time.

**Point 15.(2):** The nature of account may be Current Account or Saving account in any Nationalized bank only.

**Point 15.(8):** Balance Sheet may be read as annual statement of Income & Expenditure and Receipt & Payments duly certified by Zonal Coordinator and audited by Chartered Accountant or any State Audit Authority within one month after the end of every financial year.
