Sub: On-Boarding of RCI's recognized/approved active/latest Institutes/Colleges for on National Scholarship Portal (NSP)-reg.

Sir,

I am directed to inform you that NSP portal (<https://scholarships.gov.in/>) has already been opened for inviting applications from various categories of students including SC/ST/PwDs under various scholarship schemes of Central/State Governments. The last date for application submission for scholarship by the students is 31.12.2023. Further, it is observed that most of the institutes/colleges recognized by RCI are not onboard on NSP Portal which deprive various categories of students including SC/ST/OBC/PwDs to obtain benefits of various scholarship Schemes of Central/States Governments.

2. In this connection, the NSP-NIC team has informed that the any institute must have a valid AISHE/U-DISE/NCVT/SCVT/CBSC etc. code to onboard or register on the National Scholarship Portal. Furthermore, the details of the institute, Institute Nodal Officer (INO), and Head of Institutes (HOI) are also to be updated on NSP Portal and the Head of the Institutes (HoI)/ Institute Nodal Officer (INO) of the institutes have to undergo Aadhaar-based Biometric Authentication. In this regard, minutes dated 10.11.2023 of the meeting held on 06.11.2023 by DBT Mission, Cabinet Secretariat on progress review of National Scholarship Portal (NSP) are enclosed herewith for ready reference.

3. In view of above, Secretary, DEPwD took a meeting on 07/11/2023 and desired that RCI should ensure that all the active/latest institutes should be registered themselves on NSP Portal immediately so that various categories of the students including SC/ST/OBC/PwDs form RCI's Institutes could be benefited from various Scholarship Schemes of Central/ State Governments.

4. An Action Take Report (ATR), along with Status/details of all active institutes/colleges alongwith details of AISHE/U-DISE/NCVT/SCVT/AICTE/CBSE code, HoIs and INOs in the enclosed format at Annexure, may kindly be furnish to this Department urgently and latest by 21.11.2023 for kind perusal of Secretary, DEPwD.
