

5. All institutions are hereby instructed to download Webex App for surprise inspections and follow the norms during conduct of CRE programs to avoid any such action.
6. All the Head of Institute and programme Coordinator are instructed to comply the CRE norms in conducting the CRE Programme and if found any lacuna during surprise inspection of CRE Programme, such institutions may be **debarred for conducting CRE programme for next two years from the date of issuance of letter**. This will also be reflected on the Council's website.
