Public Notice

For conduct of proficiency test for candidates underwent Post Graduate Diploma in Community Based Rehabilitation (PGDCBR) , Diploma in Community Based Rehabilitation (DCBR) & Certificate Course in Special Education (Add on course) from un-approved Study Centres of RCI under Bangalore University (BU)

The Council has signed Memorandum of Understanding (MoU) with Bangalore University to conduct the PGDCBR, DCBR & Add on course in collaboration with RCI. It has been observed that Bangalore University has conducted the said courses at 136 unapproved Study Centers, across the country.

2. The candidates underwent the said courses from un-approved Study Centers applied for registration in CRR of RCI based on the said qualification, in absence of the authentication certificate issued by the RCI's approved Study Centre their application was regretted .

2. The Council is also pursuing the said matter with the Bangalore University from the last 10 years. Due to non submission of requisite information and documents by Bangalore University, the matter regarding regularization of registration of these candidates in CRR of RCI is not addressed appropriately till date.

3. The Council is in received of several requests and representations from individuals, students followed by VIP references for issuance of registration in CRR to these students, as in absence of RCI registration they are being deprived to apply for various posts advertised by the different departments of State/Central Govt.

4. In order to safeguard the future of these students and in the public interest, it has been decided by the Council to conduct the proficiency test to ascertain their knowledge and skills in the field of CBR prior to issue the registration certificate.

5. All the candidates who underwent PGDCBR, DCBR & Add on course from un approved Study Centers of RCI under Bangalore University during 2004-05 to 2014-15 is mandatorily required to appear in the proficiency test being conducted by the Council. The schedule and guidelines are as under:
